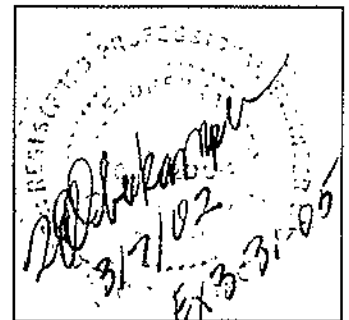

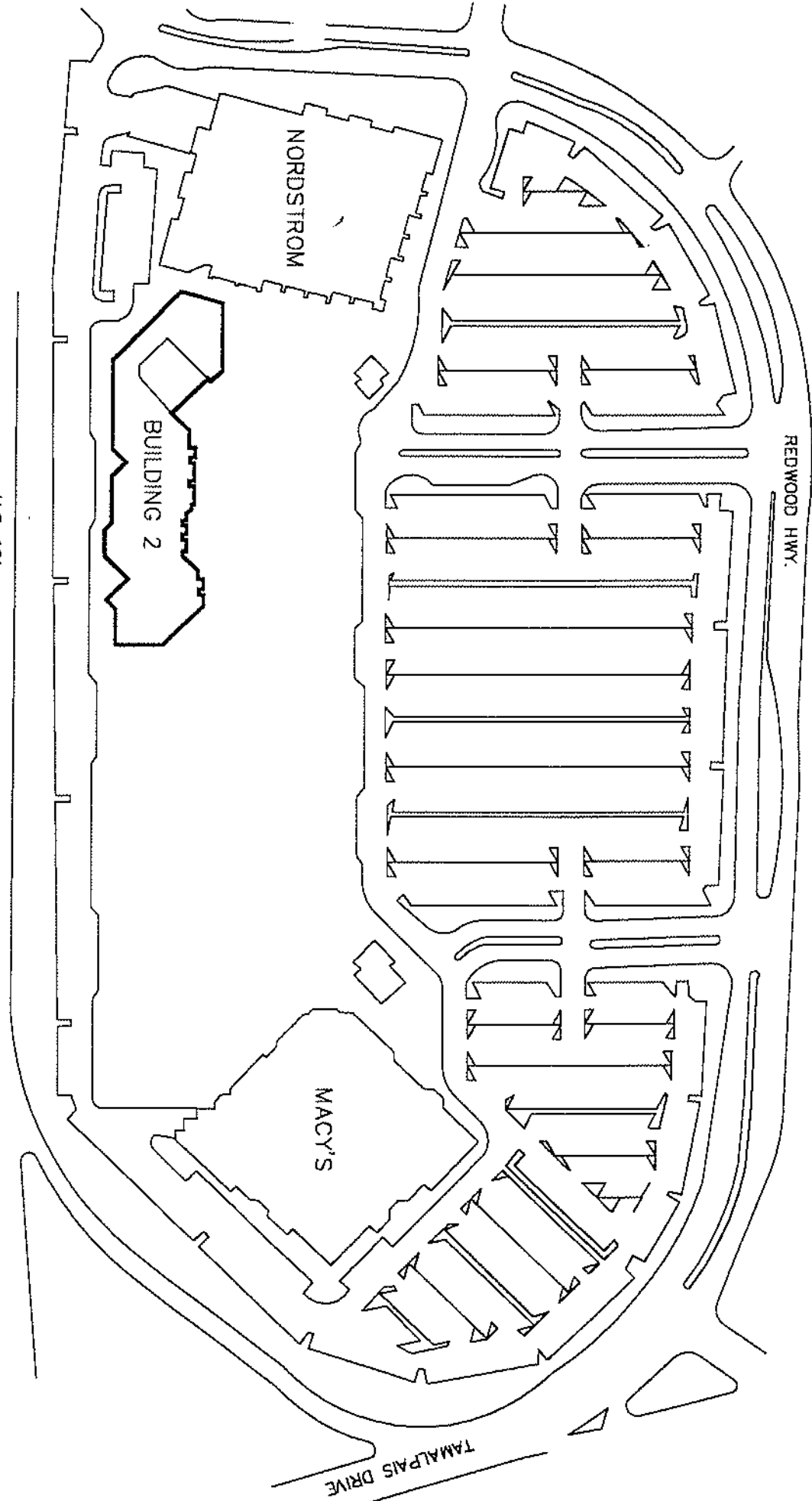

SITE PLAN


