On Tuesday, January 13, 2015 at 7:30pm at the Corte Madera Community Center, the Corte Madera Planning Commission will hold a public meeting to hear a staff presentation on the 2015-2023 Draft Housing Element, ask questions, recommend possible revisions, and consider forwarding the draft on to the Town Council for additional public meetings.

This public meeting will provide an opportunity to ask questions and better understand the content of the draft document, the 2015-2023 Housing Element process, the overall timeline, and provide comments and input on the draft itself. Additional meetings before the Town Council are tentatively scheduled for February 3rd and 17th, 2015, and would provide similar opportunity for public involvement and input.
